VALIDITY CONDITIONS

Q - Survey using Remote Inspection Techniques (RIT) as an alternative means for Close-up Survey of the structure of ships and mobile offshore units

The service recognition is for:

- Unmanned Aerial Vehicles (UAV), drones
- Climbers

Notes for conditions&restrictions;

- 1-The drone cannot be used for streaming to a remote control station other than the principal drone control station. The drone should be operated only in the presence of the Surveyor.
- 2-The drone cannot be used for thickness measurements.
- 3-The drone cannot be operated beyond visual line of sight.
- 4-The drone cannot be operated through manholes.
- 5-The drone cannot be used for Simultaneous Localization and Mapping of enclosed spaces.
- 6-The drone cannot be used in spaces where hazardous atmosphere may be present.
- 7-The drone cannot be used in spaces with Nitrogen or inerted atmosphere and can be used only in spaces where flight Beyond Visual Line of Sight (BVLOS) is not necessary.

General conditions for the approval

- a) The initial conditions verified by RINA at the time of the approval are to be maintained
- b) Any changes to the initial conditions are to be promptly communicated to RINA, which reserves the right to repeat the relevant assessments
